CONTRIBUTORS

Doug Bandow (J.D. Stanford University) is a Senior Fellow at the Cato Institute. He also is the Robert A. Taft Fellow with the American Conservative Defense Alliance and a Senior Fellow in International Religious Persecution at the Institute on Religion and Public Policy. He served as a Special Assistant to President Ronald Reagan and as a Senior Policy Analyst in the 1980 Reagan for President campaign. He has been widely published in such periodicals as *Time*, *Newsweek*, *Fortune*, *Christianity Today*, *Foreign Policy*, *Harper's*, *National Interest*, *National Review*, *New Republic*, *Orbis*, and *World*, as well as leading newspapers including the *New York Times*, *Wall Street Journal*, and *Washington Post*. Bandow has written and edited several books, including *The Korean Conundrum: America's Troubled Relations with North and South Korea* (Palgrave/Macmillan, coauthor), *Tripwire: Korea and U.S. Foreign Policy in a Changed World* (Cato), *Foreign Follies: America's New Global Empire* (Xulon Press), *Perpetuating Poverty: The World Bank, the IMF, and the Developing World* (Cato, coeditor), and *The Politics of Plunder: Misgovernment in Washington*. He has also appeared on numerous radio and television programs, including ABC Nightly News, American Interests, CBS Evening News, CNN Crossfire, CNN Larry King Live, Good Morning America, and Night-line. He received his B.S. in Economics from Florida State University in 1976.

Bruce E. Bechtol Jr. (Ph.D. Union Institute) is a Professor of International Relations at the Marine Corps Command and Staff College (2005 – present). Dr. Bechtol served as an adjunct Visiting Professor at the Korea University Graduate School of International Studies (2006-2007) and an adjunct Professor of Diplomacy at Norwich University (2005-2009). He was an Intelligence Officer at the Defense Intelligence Agency from 1997 until 2003, eventually serving as the Senior Analyst for Northeast Asia in the Intelligence Directorate (J2) on the Joint Staff in the Pentagon. Before beginning his career at the Defense Intelligence Agency, he was on active duty for 20 years in the U.S. Marine Corps, serving at various locations in the western Pacific and East Asia. Formerly the Editor of the *Defense Intelligence Journal* (2004-2005), he currently sits on the Editorial Review Board of the *East Asian Review*. In addition to serving on the Board of Directors of the International Council on Korean Studies, Dr. Bechtol sits on the Board of Directors of the Council on U.S.-Korean Security Studies. He is the author of *Red Rogue: The Persistent Challenge of North Korea* (Potomac

Books, 2007), and the editor of *The Quest for a Unified Korea: Strategies for the Cultural and Interagency Process*, (Quantico, VA: U.S. Marine Corps University Foundation, 2007).

George Alan Hutchinson is an energy policy consultant. He currently supports the Office of the Deputy Assistant Secretary of the Air Force (Energy, Environment, Safety and Occupational Health). In 2007, he retired from the United States Air Force as a Logistics Readiness Officer and qualified Foreign Area Officer, with expertise in Korean affairs and language. Before retiring, he completed an Education with Industry assignment at Exxon Mobil's Downstream Headquarters in Fairfax, Virginia, and was assigned to the Air Force Petroleum Agency in Ft. Belvoir, Virginia, where he served as Chief, Logistics Readiness and Operations Division. As a Korean linguist, he served at Osan Air Base, the Special United States Liaison, Advisor Korea, and the National Security Agency. He also attended Yonsei University's one-year Korean language program. In 1993, he was selected to attend Officer Training School, where he graduated with distinction. In 1998, his Masters thesis, *Republic of Korea Weapons Acquisition through the Post-Cold War and the Case of the SAM-X Project: Implications for US-ROK Relations*, won the Air Force Historical Foundation Award for best historical thesis. Thereafter, his articles about US-ROK arms relations have appeared in *Air Force Journal of Logistics* publications. Assignments include duty as Logistics Readiness Flight Commander at Taegu Air Base and Seventh Air Force Chief of Supply and Fuels, where he worked closely with the Republic of Korea Air Force at Osan Air Base. In 2004, Hutchinson served as the Joint Duty Officer, United Nations Command Military Armistice Commission, where he monitored Armistice compliance within the Joint Security Area in Panmunjom and was responsible for all United Nations Command and North Korean People's Army 24-hour hotline communications. He has a Bachelor of Arts in Asian Studies from the University of Maryland and a Master of Science in Logistics Management from the Air Force Institute of Technology.

Ilpyong J. Kim (Ph.D. Columbia University) is Professor Emeritus of Political Science and International Relations at the University of Connecticut, Storrs, and also served as founding President of International Council on Korean Studies (ICKS) in 1996-2000. He was Fulbright Professor at Tokyo University of Japan in 1976-1977 and at Seoul National University in 1991-1992. He was President of New England Conference of the Association for Asian Studies in 1979-1980

and also Chairman of Columbia University Faculty Seminar on Korea in 1985-1987. He was Visiting Professor at Columbia University and Visiting Scholar at Harvard University's Fairbank Center for East Asian Research. He has lectured at Brown, Indiana, Princeton, and Yale Universities and also lectured on "U.S. Foreign Policy" at American Cultural Centers in Japan, Korea, and Southeast Asia under the auspices of the United Information Agency of the State Department. He has also participated in the Scholar-Diplomat Program at the State Department and the research seminars organized by the Bureau of Intelligence and Research (INR) of the State Department in the 1970s. He was a ROK Army Officer during the Korean War and was awarded the U.S. Bronze Star Medal for his distinguished service and bravery in 1953. Dr. Kim worked at the East-West Center in early 1960s and taught at various universities in the United States for the past 35 years. His specialty is Comparative Politics and International Relations of East Asia. Thus he has authored or edited a dozen books and contributed more than thirty-eight articles to academic and professional journals and edited volumes. His chapter on "South Korea's Transition to Democracy" was published in *Encyclopedia of Democracy* by the Congressional Quarterly Press in Washington. Dr. Kim has also served as editor of five volume series "China in New Era" of which *Chinese Politics from Mao to Deng*; *Chinese Defense and Foreign Policy*; *Chinese Economic Reform*; and *Reform and Transformation in Communist System* (with Jane Shapiro Zacek) have been published to wide acclaim. He has edited *Korean Challenges and American Policy* and *The Two Koreas in Transition: Implication for U.S. Policy* (1998). His most recent book, *Historical Dictionary of North Korea*, was published in March 2003.

Mark Manyin (Ph.D. Tufts University) is a Specialist in Asian Affairs at the Congressional Research Service (CRS), a non-partisan agency that provides information and analysis to Members of the U.S. Congress and their staff. At CRS, Dr. Manyin's general area of expertise is U.S. foreign economic policy toward East Asia, particularly Japan, the Koreas, and Vietnam. He also has tracked the evolution of terrorism in Southeast Asia and currently is working on a project identifying environmental causes of security tensions in Asia. From 2006-2008, Dr. Manyin served as the head of the CRS' 11-person Asia Section, overseeing the Service's research on East, Southeast, and South Asia as well as Australasia and the Pacific Islands. Prior to joining CRS in 1999, He has written academic articles on Vietnam and Korea, taught courses in East Asian international relations, worked as a business consultant,

and lived in Japan for a total of three years. Co-Author **Mary Beth Nikitin** is an Analyst in WMD Nonproliferation in the Foreign Affairs, Defense and Trade Division of the Congressional Research Service (CRS), Library of Congress. From 2002 to 2007, she was a Research Associate and then Fellow at the Center for Strategic and International Studies (CSIS). Previously, she worked at the Center for Nonproliferation Studies in Monterey, CA and the UN Department for Disarmament Affairs in New York. She holds a Masters in International Policy Studies from the Monterey Institute of International Studies and a Bachelor of Arts from Dartmouth College.

Yoon-Shik Park (DBA Harvard University; Ph.D. George Washington University) is Professor of International Finance at George Washington University in Washington, D.C. In addition to George Washington University, he also taught at Georgetown University and Columbia University. Dr. Park currently serves as Editor to *International Journal of Korean Studies*. Among his many publications are five books such as *The Korean Bond Market: Post Asian Crisis and Beyond*, *Project Financing and International Financial Markets*, *International Banking in Theory and Practice*, *Oil Money and the World Economy*, and *The Eurobond Market: Function and Structure*. He also served as co-editor of a book, *International Banking and Financial Centers*. He has also written a number of articles and reports in the fields of international banking and finance. Before joining the academia, he had worked for the World Bank as a Senior Economist in the 1970s. Dr. Park has also been a consultant to the World Bank, Asian Development Bank, International Finance Corporation (IFC), Inter-American Development Bank, U.S. Agency for International Development (AID), U.S. Federal Reserve, U.S. Overseas Private Investment Corporation (OPIC), U.S. Export-Import Bank, New York State Banking Department, Kuwait Institute of Banking Studies, and other private and public institutions around the world. He has also served on the board of directors of Samsung Corporation in Korea and the Korea Economic Institute of America, Inc. in Washington.
