CONTRIBUTORS

Bruce E. Bechtol, Jr. (Ph.D. Union Institute) is a Professor of International Relations at the Marine Corps Command Staff College (2005 – present). Dr. Bechtol served as an adjunct Visiting Professor at the Korea University Graduate School of International Studies (2006 – 2007) and an adjunct Professor of Diplomacy at Norwich University (200 – 2009). He was an Intelligence Officer at the Defense Intelligence Agency from 1997 until 2003, eventually serving as the Senior Analyst for Northeast Asia in the Intelligence Directorate (J2) on the Joint Staff in the Pentagon. Before beginning his career at the Defense Intelligence Agency, he was on active duty for 20 years in the Marine Corps, serving at various locations in the western Pacific and East Asia. Formerly the Editor of the *Defense Intelligence Journal* (2004 – 2005), he currently sits on the Editorial Review Board of the *East Asian Review*. In addition to serving on the Board of Directors of the International Council on Korean Studies, he also sits on the Board of Directors of the council on U.S.-Korean Security Studies. He is the author of *Red Rogue: The Persistent Challenge of North Korea* (Potomac Books, 2007), and the editor of *The Quest for a Unified Korea: Strategies for the Cultural and Interagency Process*, (Quantico, VA: Marine Corps University Foundation, 2007). His next book is entitled, *Defiant Failed State: The North Korean Threat to International Security*, (Potomac Books, 2010).

John E. Endicott: Dr. Endicott's areas of specialization include all aspects of Japanese and Korean studies, Asian security studies, with special emphasis on the Korean Peninsula, American defense policy, and professional military education. His published books include, *Japan's Nuclear Option*, *The Politics of East Asia*, *American Defense Policy*, and *Regional Security Issues*. A book on American foreign policy written by Endicott and two colleagues, *U.S. Foreign Policy: History, Process, and Policy*, was published in 2004. His most recent work on East Asian politics, history, culture, and economics, in conjunction with his wife, Mitsuyo, and others is in final edit at the Southern Center for International Affairs of Atlanta, Georgia. He received his Ph.D. from the Fletcher School of Law and Diplomacy of Tufts University in cooperation with Harvard University. He has a Masters Degree in Law and Diplomacy, and a Masters Degree in International Affairs also from Fletcher, his Masters Degree in History is from the University of Omaha, and his BA in Political Science is from Ohio State University. Dr. Endicott came to Woosong University and SolBridge International from the Georgia Institute of Technology where he served as Professor, the

Sam Nunn School of International Affairs. Dr. Endicott previously had a 28-year career in the United States Air Force. He also served as a member of the Senior Executive Service of the Department of Defense. As an officer of the United States Air Force, he held the positions of Director, International Affairs for the Planning Directorate of Air Force Headquarters, the Pentagon; Deputy Air Force Representative to the Military Staff Committee of the Security Council, the United Nations; and Associate Dean of the National War College.

Mel Gurtov (Ph.D. UCLA) is Professor Emeritus of Political Science and International Studies at Portland State University, Oregon, and is currently Visiting Professor of Political Science at the University of Oregon, Eugene. He is also Editor-in-Chief of *Asian Perspective*, a position he has held since 1994. Dr. Gurtov previously served on the research staff of the RAND Corporation in Santa Monica, California (1966-71), where he was a co-author of the Pentagon Papers, and at the University of California, Riverside (1971-86), where he was Professor of Political Science. He has published twenty books and numerous articles on East Asian affairs, U.S. foreign policy, and global politics, all from a human-security viewpoint. His most recent books are *Superpower on Crusade: The Bush Doctrine in US Foreign Policy* (Lynne Rienner, 2006) and *Global Politics in the Human Interest*, 5th ed. (Lynne Rienner, 2007). Dr. Gurtov has been a visiting professor and Senior Fulbright Scholar –at Waseda University in Tokyo and Hankuk Foreign Studies University in Seoul –and he has lectured at universities and research institutes in South Korea, Japan, and China.

David C. Kang is Professor at the University of Southern California, with appointments in both the School of International Relations and the Marshall School of Business. At USC he is also Director of the Korean Studies Institute. Dr. Kang is author of *China Rising: Peace, Power, and Order in East Asia* (Columbia University Press, 2007); *Crony Capitalism: Corruption and Development in South Korea and the Philippines* (Cambridge University Press, 2002), and *Nuclear North Korea: A Debate on Engagement Strategies* (co-authored with Victor Cha) (Columbia University Press, 2003). He has published numerous scholarly articles in journals such as *International Organization* and *International Security*, as well as opinion pieces in the *New York Times*, the *Financial Times*, the *Washington Post*, the *Los Angeles Times*, and numerous Korean and Chinese newspapers. He is also a regular consultant for both multinational corporations and U.S. government agencies, such as the CIA, National Intelligence Council, and the State

Department. Professor Kang was previously Professor of Government and Adjunct Professor at the Tuck School of Business, Dartmouth College. He has been a visiting professor at Stanford University, Yale University, Seoul National University, Korea University, and the University of Geneva. He received an A.B. with honors from Stanford University and his Ph.D. from Berkeley.

Hong Nack Kim (Ph.D., Georgetown University) is Professor of Political Science at West Virginia University. Dr. Kim was a visiting Fulbright Professor at Keio University (1979-82) and Fulbright Professor of Political Science at Seoul National University during the academic year 1990-9. After graduating from Seoul National University (B.A. in Political Science), he has received Masters, and Ph.D. Degrees in Political Science from Georgetown University. From 1983 to 1985, he served as the president of the Association of Korean Political Scientists in North America. After serving as president of the International Council on Korean Studies (2004-08), he is currently chairman of the Board of Directors of the International Council on Korean Studies. Formerly Editor-in-Chief of the *International Journal of Korean Studies*, he has written widely on East Asian affairs, contributing over 130 articles to academic journals. In addition he has contributed several articles to *Colliers Encyclopedia Yearbook* (1978, 1979, 1988, 1989, and 1990) and *1981 Yearbook on International Communist Affairs* (Hoover Institution Press). He has also authored or edited seven books, including *North Korea: The Politics of Regime Survival* (M.E. Sharpe, 2006). In the fall semester of 2005, he was a Visiting POSCO Fellow at the East-West center, Honolulu, Hawaii. He is a recipient of the outstanding research award from the Eberly College of Arts and Sciences, West Virginia University (1985).

Dick K. Nanto is a Specialist in Industry and Trade (senior level) and former Head of both the International Trade and Finance section and the Asia section at the Congressional Research Service of the Library of Congress. He works primarily on U.S. trade and financial relations with, and economic conditions in Asia. He received his Masters, and Ph.D. degrees in Economics from Harvard University, a Masters degree from the National War College in National Security Studies, and formerly was an Assistant Professor of Economics at Brigham Young University and Adjunct Professor Lecturer at Johns Hopkins University. He has published numerous journal articles, reports, and chapters in books.
