## CONTRIBUTORS SPRING/SUMMER 2011 IJKS

**Bruce E. Bechtol, Jr.** is a Professor of International Relations at the Marine Corps Command and Staff College. He previously was on the faculty of the Air Command and Staff College (2003-2005). He was an Intelligence Officer at the Defense Intelligence Agency from 1997 until 2003, eventually serving as the Senior Analyst for Northeast Asia in the Intelligence Directorate (J2) on the Joint Staff in the Pentagon. Before beginning his career at the Defense Intelligence Agency, he was on active duty for 20 years in the U.S. Marine Corps, serving at various locations in the western Pacific and East Asia. Formerly the Editor of the *Defense Intelligence Journal* (2004-2005), he also sat on the Editorial Review Board of the *East Asian Review* (2005-2009). He has written widely on Korean security issues, contributing articles to such journals as the *International Journal of Korean Studies*, *Pacific Focus*, *Contemporary Strategy*, *Foreign Policy*, and the *Korea Observer*. In addition to serving on the board of directors of the International Council on Korean Studies, Dr. Bechtol sits on the board of the Council on U.S.-Korean Security Studies. He is the author of *Defiant Failed State: The North Korean Threat to International Security* (Potomac Books: 2010), *Red Rogue: The Persistent Challenge of North Korea* (Potomac Books, 2007), and the editor of *The Quest for a Unified Korea: Strategies for the Cultural and Interagency Process*, (Quantico, VA: Marine Corps University Foundation, 2007).

**Victor D. Cha** is Senior Adviser and inaugural holder of the newly created Korea Chair at the Center for Strategic and International Studies (CSIS). Previously, he served as director for Asian affairs at the White House National Security Council, where he was responsible for coordinating U.S. policy for Japan, the two Koreas, Australia, New Zealand, and the Pacific Island nations. He also served as U.S. deputy head of delegation to the Six-Party Talks and has acted as a senior consultant on East Asian security issues for different branches of the U.S. government. A recipient of numerous academic awards, including the prestigious Fulbright scholarship (twice) and MacArthur Foundation fellowship, Dr. Cha spent two years as a John M. Olin National Security Fellow at Harvard University and as a postdoctoral fellow at Stanford University's Center for International Security and Cooperation. He also teaches as the D.S. Song professor of government and Asian studies at Georgetown University. Dr. Cha's numerous books include *Beyond the Final Score: The Politics of Sport in Asia* (Columbia University Press,

2009), *Nuclear North Korea: A Debate on Engagement Strategies* (Columbia University Press, 2003), and *Alignment Despite Antagonism: The U.S.-Korea-Japan Security Triangle* (Stanford University Press, 1999). He is also a frequent contributor and guest analyst for various media outlets in Korea and the United States.

**Myongsei Kang** is Senior Fellow at the Sejong Institute. Kang is author of *Labor Market and Political Market in South Korea* (Paiksan Press, 2006); *The Politics of Welfare and Labor in Global Age* (Hanwool Press, 2009), and *Survival Strategies of Small States in World Economy* (co-edited with J. Shim, Korean Political Science Association, 2005). He has served as a committee chairman to evaluating research activities for law-making of Representatives of National Assembly since 2009. He has published numerous scholarly articles in Korean journals such as *State Strategies* (where he served as chief editor for two years), as well as opinion pieces in numerous Korean newspapers. He had worked as a chief editor of the *Korean Political Science Review* in 2004. Kang also was an adviser to the Minister of Labor in South Korea in 1998-2000.

**Samuel S. Kim** is Senior Research Scholar at Columbia University's Weatherhead East Asian Institute and editor-in-chief of the "Asia in World Politics" series of Rowman & Littlefield Publishers. He previously taught at Monmouth University (1966-85), Foreign Affairs Institute, Beijing, China (1985-86), Princeton University (1986-93) and Columbia University (1993-2006). He is the author or editor of twenty-three books and about 160 articles on East Asian international relations (especially Chinese and Korean foreign relations) and peace and world order studies. Among his books are *China, the United Nations and World Order* (Princeton University Press 1979); *The War System: An Interdisciplinary Approach* (with Richard A. Falk, Westview Press 1980); *The Quest for a Just World Order* (Westview Press 1984); *North Korean Foreign Relations in the post-Cold War Era* (ed., Oxford University Press 1998); *Korea's Globalization* (ed., Cambridge University Press 2000); *East Asia and Globalization* (ed., Rowman & Littlefield 2000); *Korea's Democratization* (ed., Cambridge University Press 2003); *The International Relations of Northeast Asia* (ed., Rowman & Littlefield 2004); *The Two Koreas and the Great Powers* (Cambridge University Press 2006); and *North Korean Foreign Relations in the Post-Cold War World* (Strategic Studies Institute 2007).

**James I. Matray** is professor of history at California State University, Chico, where he completed his final term as department chair in August 2008. He has published more than forty articles and book chapters on U.S.-Korean relations during and after World War II. Author of *The Reluctant Crusade: American Foreign Policy in Korea, 1941-1950*, recipient of the Phi Alpha Theta Book Prize in 1986, and *Japan's Emergence as a Global Power*, his most recent books are *Korea Divided: The 38<sup>th</sup> Parallel and the Demilitarized Zone* and *East Asia and the United States: An Encyclopedia of Relations Since 1784*. In addition to editing two other books, Matray has published fifty encyclopedia entries and more than eighty book reviews in leading journals. In 1988, he was a recipient of the Donald C. Roush Award for Excellence in Teaching at New Mexico State University. During 2003 and 2004, Matray was an international columnist for the *Donga Ilbo* in South Korea. From 2005 to 2007, he served on the Board of Editors for *Diplomatic History*. Matray currently is preparing a monograph on the Battles of Pork Chop Hill for publication by Indiana University Press in its "Twentieth Century Battles" series.

**Patrick M. Morgan** is Professor of Political Science and Tierney chair in Global Peace and Conflict Studies at the University of California, Irvine. A co-founder of the Council on US-Korean Security Studies, he serves on its Board and prepares the annual reports on the Council conferences. He is a specialist on national and international security affairs, with an emphasis on deterrence and arms control, and on Northeast Asian security affairs. His writings include *Deterrence: A Conceptual Analysis* (two editions), *Deterrence Now* (Cambridge University press, 2003), and—co-edited with T. V. Paul and J. Wirtz—*Complex Deterrence* (University of Chicago Press, 2009), along with several other books and numerous articles in academic journals. His current major project is a book about the future of the US alliances, using the US-ROK alliance as the major case study, and he is also involved with several other analysts in a project on the future of American extended deterrence in East Asia.

**Terence Roehrig** is an Associate Professor in National Security Studies at the Naval War College in Newport, Rhode Island. He is a coauthor with Uk Heo of a forthcoming book entitled *South Korea since 1980: Democratization, Economic Struggle, and Nuclear Crisis* (Cambridge University Press). In addition, he is the author of two other books, *From Deterrence to Engagement: The U.S. Defense Commitment to South Korea* (Lexington, 2006) and *The Prosecution of Former Military*

*Leaders in Newly Democratic Nations: The Cases of Argentina, Greece, and South Korea* (McFarland, 2002) along with a monograph, *Korean Dispute Over the Northern Limit Line: Security, Economics, or International Law?* (University of Maryland Law School, 2008), and is the co-editor of *Korean Security in a Changing East Asia* (Praeger 2007). He has published articles and book chapters on North Korea's nuclear weapons program, Korean and East Asian security issues, the U.S.-South Korea alliance, human rights, and transitional justice. Dr. Roehrig is a past president of the Association of Korean Political Studies.

**Andrew C. Scobell** is Senior Political Scientist at the RAND Corporation's Washington, D.C. office. Prior to that he was Associate Professor of International Affairs at the Bush School of Government and Public Service at Texas A&M University. From 1999 until 2007, he was Associate Research Professor in the Strategic Studies Institute at the U.S. Army War College and Adjunct Professor of Political Science at Dickinson College, both in Carlisle, Pennsylvania. From 1994 to 1999, he taught at the University of Louisville. He is the author of *China's Use of Military Force: Beyond the Great Wall and the Long March* (Cambridge University Press, 2003) and co-author (with Andrew J. Nathan) of *China's Search for Security* (Columbia University Press, forthcoming). He has authored or co-authored more than a dozen monographs and reports and has edited and co-edited more than ten volumes on Asian security. His work has appeared in the following journals: *Armed Forces and Society*, *Asian Security*, *Asian Survey*, *Brookings Review*, *China Quarterly*, *Comparative Politics*, *Current History*, *Issues and Studies*, *Journal of Contemporary China*, *Journal of Political and Military Sociology*, *North Korean Review*, *Parameters*, *Political Science Quarterly*, *Taiwan Defense Affairs*, and *World Policy Journal*.
